MASSIVE CASH JACKPOT RULES

1. The Massive Cash Jackpot payouts are available on eligible Class III slot and video poker machines.
2. Must be 18 years or older and a member of The Club to participate.
3. Club Members must have their own Player's Club Card properly inserted into the card reader to be eligible to win a Massive Cash Jackpot.
4. Table Mountain Casino employees and their immediate family members (spouse, parents, children, siblings and/or grandparents) are not eligible to win a Massive Cash Jackpot.
5. Winners are chosen at random from all active carded sessions.
6. System and/or machine malfunctions void all pays.
7. Massive Cash Jackpot is completely independent of the slot or video poker machine's game outcome.
8. It is the Club Member's responsibility to ensure their own Player's Club Card is properly inserted into the machine. Guests whose Player's Club Card is not properly inserted in the machine's card reader are not eligible to win.
9. Massive Cash Jackpot — starts at \$50,000 and is guaranteed to hit by \$150,000. The Massive Cash Jackpot is paid in cash.
10. To be eligible to win a Massive Cash Jackpot, the Club Member must also comply with the following:
 - i. Guest must be playing with their own Player's Club Card properly inserted into the slot or video poker machine's card reader.
 - ii. Patrons who are using someone else's Player's Club Card are not eligible to win or collect a Massive Cash Jackpot.
 - iii. Club Members who allow another person to use their Player's Club Card are not eligible to collect a Massive Cash Jackpot awarded to a machine being played by someone else who was using the Club Member's Player's Club Card.
 - iv. When a Massive Cash Jackpot is awarded, the guest must stay at their machine until the win has been verified. A slot attendant will notify the Club Member playing at the randomly chosen machine that they may be a winner.
 - v. The potential winner must have acceptable valid photo identification available immediately upon request that matches the name on the Player's Club Card inserted into the machine when Massive Cash Jackpot hits or which matches the name on file with the Player's Club Card. Club Members who cannot provide matching photo identification may be disqualified. Winners must also present their social security card, if the guest does not have their social security card with them, then they must fill out a W9 form. Failure to do so will result in prize forfeiture. Any forfeited prize will not be re-awarded.
 - vi. By accepting a Massive Cash Jackpot payout, you grant Table Mountain Casino permission to take and use your photograph, name and likeness in any of Table Mountain Casino's advertising and/or publicity purposes at no additional compensation.
 - vii. Taxes will be withheld pursuant to the IRS guidelines and Table Mountain Casino jackpot policies.
 - viii. Massive Cash Jackpot payouts are non-transferable.
11. All decisions regarding these rules by Table Mountain Casino Management shall be final, unless subject to Casino Patron Dispute Resolution Procedures.
12. Management shall reserve the right to alter or cancel promotions without prior notice.
